# IS A FAD DIET RIGHT FOR YOU?

As we enter the summer months full of sun, pools, and swimming suits, people are searching for ways to lose inches. Sometimes this search leads them towards a type of "fad diet" promising quick weight loss. Fad diets are a big business in the United States with over 1,500 books published each year and consumers willing to pay into this 35 billion dollar per year industry promising quick results. Moreover, 14-15% of Americans claim that they have used or are currently on a fad diet for quick weight loss.

Fad diets are not right for everyone, and the question to ask yourself is if they are right for you. The best way to determine this is to research what these diets entail and decide if it is something you can realistically follow and sustain over the long term. Most fad diets fail because they are difficult to sustain due their restrictive nature. For purposes of this article, I would like to focus on two of the most popular fad diets, the Keto and intermittent fasting diets.

The Keto diet was developed by Registered Dietitians in the 1920s designed to treat epilepsy in children. The diet is composed of less than 30 grams of carbohydrate, moderate protein, and 70-80% of total calories coming from fat per day. It is designed to induce long-term nutritional ketosis and, according to studies, is effective in helping people lose weight. The problem for most is adhering to the

diet and staying in ketosis. In a 2-year study conducted in 2022, adherence to this diet fell from 60% of individuals to only 7%. Additionally, following a Keto diet has some possible health concerns to include the initial "keto flu" as the body begins to transition to ketosis. Also, electrolyte imbalances and Calcium, Vitamin D, Magnesium, B Vitamins, and Iron deficiencies can arise. The diet can also result in gout, osteoporosis, hypoglycemia and dehydration incidents, and kidney stones along with cardiovascular disease if people consistently consume saturated and trans-fatty acids as their primary fat source.

Another popular diet is intermittent fasting which has been around for thousands of years. People tend to use intermittent fasting practices for religious reasons or to lose weight. There are a few intermittent fasting schedules most follow to include alternate day fasting, whole day fasting, or time-restricted feeding. Alternate day fasting involves alternate days of no restriction and days that provide about 25% of total calorie needs. An example would be 5 days of normal eating and 2 days of fasting. Whole day fasting involves 1-2 days per week of complete fasting and time-restricted feeding involves eating during a condensed time. An example of time-restricted feeding is eating between 8 AM and 2 PM and fasting between 2 PM and 8 AM. In a Harvard study conducted in 2017 that included 12 clinical trials and compared intermittent fasting to continuous calorie reduction diets, there was no significant weight loss or body composition differences between the two. Additionally, there are some nutritional risks with intermittent fasting to include hypoglycemia episodes, binge eating after periods of fasting, inadequate energy intake if engaging in physical activity, and impact of medications that require food intake.

In my 27-year practice as a Registered Dietitian, I have seen a few people

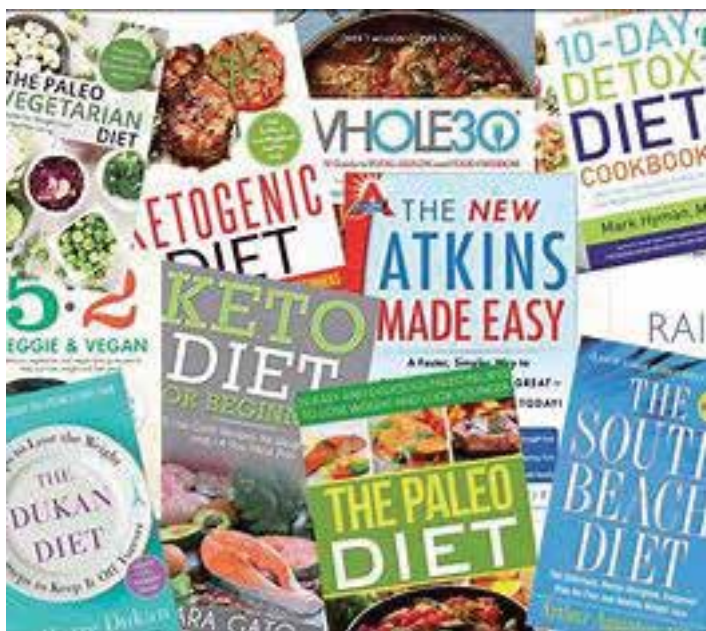

succeed on these diets, but most, unfortunately, cannot sustain their restrictive nature and often gain back the weight they initially lost. My advice for everyone is to find a balanced, healthy way of eating that works best for you in meeting your goals. When seeking this out, do your research using reputable resources and learn what works best for you over the long haul!

### Portable Charger

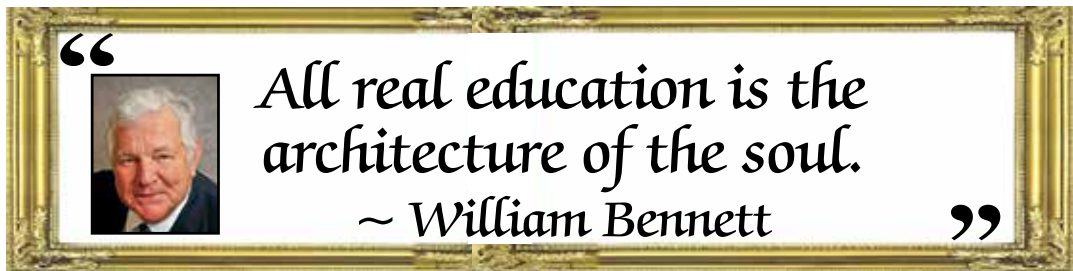

# Taste of Wine & Food

## NAPA VALLEY GIRL POWER WINE DINNERS MARKHAM AND HALL

**Story by Rico Cassoni.**

West End Bar & Kitchen and The Butcher Shop hosted wine dinners from two renowned Napa Valley wineries. The first was a Markham Winemaker Dinner with Kimberlee Nicholls at West End and the second was a Hall Wine Dinner at The Butcher Shop.

As a brief history of Markham, Frenchman Jean Laurent left Bordeaux, France in 1852 to join the California Gold Rush, eventually establishing one of Napa Valley's first wineries. He founded the winery in 1874 and built an iconic stone cellar in 1879, which remains the heart of Markham Vineyards today. By the century's end, Laurent was a major figure in Napa's wine industry, and was known for adopting new technologies and equipment. In the late 1970s, Arizona businessman Bruce Markham invested in 230 acres of vineyards, a bungalow, and Laurent's old stone cellar, coinciding with Napa Valley's rising fame from the "Judgment of Paris." Winemaker Bryan Del Bondio's 42-year tenure earned a stellar reputation for the winery, which produced its first vintage of Markham Cabernet Sauvignon in 1978 and Merlot in 1980. Wine Spectator named the 1990 Markham vintage "Merlot of the Year." Kimberlee Nicholls, was hired as an enologist in 1993, and then became head winemaker in 2001, one of Napa Valley's first female head winemakers. Her over 30 years of experience and love of Merlot contributes to Markham's enduring legacy and numerous accolades.

Nicholls is one of Markham's Girl Power, Dream Team. Abigail Estrada, Assistant Winemaker, Patricia Sciacca, Enologist, Taylor Abudi, Viticulturist, and Adrienne Uboldi, Director of Operations are the other key players.

Chef Brian Gist prepared a powerhouse menu for the evening that started with pan seared sea scallops and 2018 Argyle Brut sparkling wine created in Willamette Valley AVA in Oregon. The Brut was Chardonnay and Pinot Noir dominant with a splash of Pinot Meunier. Argyle is a sister brand to Markham within the Distinguished Vineyard Distributor family. The second course was endive salad topped with fried goat cheese served with 2022 Markham Sauvignon Blanc (100%).

The stainless steel fermentation and 4 months stainless steel aging created a crisp and refreshing Sauvignon Blanc with grapefruit and a hint of lime on the palate. Gist had duck prosciutto with a flavorful dark cherry risotto paired with a 2019 Markham Merlot for the third course. Merlot put Markham on the map as a Napa Valley player. For the main course, Gist had espresso rubbed New York Steak with crispy oven roasted Brussel sprouts. Both were topped with a dynamite bacon jam taking them to the next level, especially when paired with 2019 Napa Valley Cabernet

Sauvignon blended with Petit Verdot, Merlot, and Cab Franc. Nicholls spoiled guests with premium 2017 The Character Estate Vineyard Bordeaux. Of the 6,000 barrels of wine in Markham's cellar, only 10 barrels made the cut to produce mind blowing The Character a Merlot dominant blend (94%) from their Yountville estate. **Hall Vineyards**

Just as in the case of the Markham Wine Dinner, Gist wowed guests with a delicious five course dinner. Dinner started with a salmon tartar with pickled red onion and toasted points paired with 2022 Hall Napa Valley Sauvignon Blanc. The stainless steel fermentation produced a bright palate with citrus notes that melded nicely with the tartar. The second course was pan-seared sea bass with creamed spinach in a citrus brown butter garnished with diced pear served with 2020 Walt Sonoma Coast Chardonnay. The aromatic nose with vanilla, pear, and lemon and smooth palate with 25% new French oak was perfect with the sea bass and citrus brown butter.

For the third course, Gist served a red wine bucatini dish that included a perfect lamb meatball. Boiling the bucatini in a red wine/water solution, produced noodles that were red in color. This was paired a 2021 Walt Sonoma County La Brisa Pinot Noir.

For the main course, guests were served a coco rubbed dry aged New York Strip steak with wild mushroom risotto and roasted Brussel sprouts. This was paired with a side-by-side comparison of 2020 Hall Cabernet Sauvignon vs flagship 2020 Kathryn Hall Cabernet

Sauvignon that earned a Robert Parker 100-point score for the 2016 vintage. The Kathryn Hall Cabernet

Sauvignon blended with Cab Franc and Merlot, aged in 70% new French Oak for 26 months was a superstar and beautiful pairing for the main course. Dinner concluded with a vanilla bean gelato with a spiced red wine black

berry syrup that was paired with 2019 Baca Dry Creek Valley Zinfandel that is overseen by Kathryn's daughter Jennifer Brown. See more information on Hall at [hallwines.com](http://hallwines.com).

In summary, two excellent wine dinners with Napa Valley Girl Power Markham and Hall Wineries.

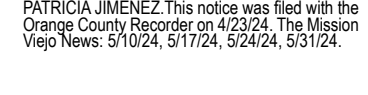
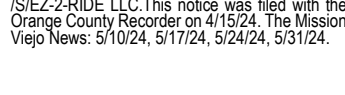

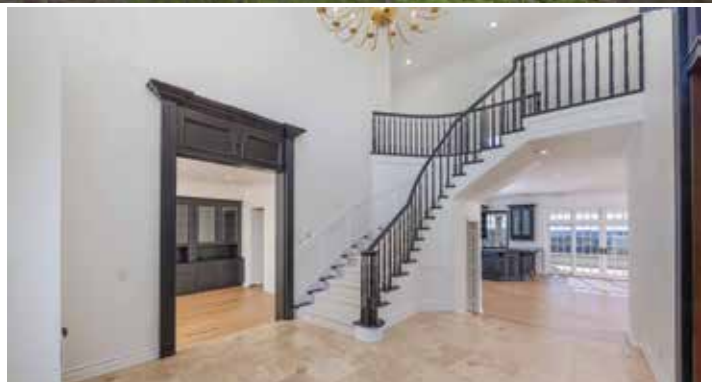
